AFMI -0401	Risk Management Intern	Assist with business cycle and macroeconomic analysis; update and maintain the AFMI exposure report and ad hoc financial market research projects
BBP – 0502	Strategy Consultant	Projects change from year to year intern will assist with: competitive analysis reports; present research findings to CEO, conduct market analysis; collect and analyze data; develop marketing initiatives; assist with financial models and business cases; assist with economic impact and calculations of details in project plans and conduct research on market trends, consumer needs etc.
